Celebrating GMEA 2024

Mr. Sanjiv Mehta's perspective on Sustainability in Manufacturing

A couple of weeks back I was invited to give a keynote address at the Green Manufacturing Excellence Awards ceremony which promotes sustainability in manufacturing. This was organised by Futurescaper.

I shared my thoughts on 'the sustainability imperative' on a wider canvas, practical examples of what Unilever and more specifically HUL has done on sustainability over the years, the key aspects of green manufacturing and the principles which companies can adopt when they embark on the road to sustainability.

One aspect I would like to share today is on the important subject of ..Does it pay to be green?

Very often the debate is framed in a simplistic yes or no. Academics and environmentalists say yes. The underlying assumption is that our earth is sick and therefore it ought to be profitable to find ways to get it to good health. This is faulty reasoning. The hard truth is that environment problems do not automatically create opportunities to make money. On the other hand, the stance that it never pays to invest in environment initiatives is also wrong. Some approaches that a company can take to integrate the environment initiatives into business cases and models are:

- Distance yourself from competitors by differentiating your products from sustainability perspective and command higher prices
- Sustainability initiatives when done prudently could help reduce costs
- The three axis of innovation work should be around superior products which meet the unmet needs, lower costs and sustainable products.
- Mitigate risks and reduce the expenses linked to lawsuits, accidents and boycotts
- Make systemic changes and redefine your competitors / markets

The appeal of any of the above approaches will depend on time horizon and the capabilities of an organization.
